## **MINUTES**

The monthly meeting of the Board of Directors of COMMUNITY SERVICE ASSOCIATION was held on Thursday, December 13, 2012, at Harold Ballard Parent Center, Room 3. Chairperson Williams called the meeting to order at 4:10 p.m.

Board members welcomed Cheryl Ward. Ward was recently elected to the CSA Board of Directors to represent administrators and will begin her term of office on January 1, 2013. Since the next meeting is a dinner meeting, Fettig thought it would be easier if introductions took place at a regular meeting. Everyone introduced themselves and gave their current work locations and assignments.

Fettig reported that Diane Harrelson slipped and fell in the Eugene Brucker Education Center parking lot as she was leaving work the night of December 11. Diane broke her jaw and injured a wrist. Fortunately, surgery was not needed. Fettig will follow-up on Diane's condition and will send a plant and get-well card from the CSA Board of Directors to wish her a speedy recovery.

<u>Minutes</u>: Motion by Levine/Fairley Jr. to accept the November 8, 2012, minutes as presented passed unanimously.

**<u>Financial Reports</u>**: Financial report for November was reviewed and accepted.

**Board Member Election Report**: Fettig reported that Cheryl Ward was elected to represent administrators and Harrelson and Williams were reelected to serve 3-year terms of office. There were also a few write-in candidate names that Fettig will keep on file in the event of future board vacancies.

<u>Publicity</u>: The \$6,000 holiday donation check to Children & Youth in Transition was presented to Rebecca Benner, program manager, by Harrelson, Levine and Stultz. An article about CSA and the Children & Youth in Transition program along with a photo of the presentation were submitted to the Communications Department for the district website. The article and photo were also included in the *Kids on the Move Newsletter*, issued by the Children & Youth in Transition Program.

<u>Preliminary Report of Annual Membership Drive Campaign</u>: Report submitted by Bartholomew that there are 38 new members compared to 286 last year resulting in a decrease of 148 new members. Members who increased their donations totaled 26 and members who decreased their donations totaled 14. In addition, 3 members dropped. (See attached report for complete membership information.)
